## Extract from the Articles of Association

**Article 4** Any person, Firm or Company carrying on banking, shipping, insurance, broking, mercantile or other business of a commercial character and for the purposes of its business, having an office or representative in Singapore, shall be eligible for membership.

**Article 5** Any Firm or Company eligible for election shall, if elected, become a member in their conventional or corporate name.

**Article 15 (a)** If any Member in the opinion of the Board fails to conform to any of the published rules and regulations of the Chamber, or is guilty of conduct derogatory to the dignity of or injurious to the reputation or interests of the Chamber, the Board may by notice invite such a Member to resign membership.
